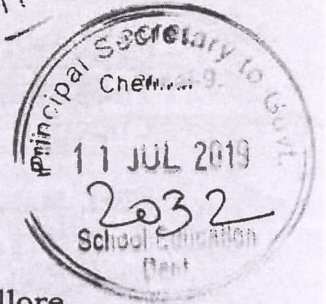
The poll day of General Election to 8. Vellore Parliamentary Constituency, 2019 has been announced as 05.08.2019 (Monday). It is proposed to declare 05.08.2019 (Monday) the poll day, as a public holiday for the areas comprised in 8. Vellore Parliamentary Constituency under the Negotiable Instruments Act, 1881.

2. With a view to give the workers in factories and establishments under the Government, an opportunity to vote, it is necessary to grant them a paid holiday as was done during the previous General Elections. I am to state that Section 135B of the Representation of the People Act, 1951 provides for the grant of holiday on the poll day, with wages for every person employed in any business, trade, industrial undertaking or any other establishment.

3. I am, therefore, to request you to issue orders allowing a **paid holiday on the poll day i.e. 05.08.2019 (Monday) to the workers and other employees, who are employed in factories and Public Sector Undertakings under your administrative control.**

**Subject : Schedule for election to 8-Vellore Parliamentary Constituency of Tamil Nadu-  
Regarding.**

Notification calling General Election to 8-Vellore Parliamentary Constituency of Tamil Nadu vide Notification No.464/EPS/2019(2) dated 19.03.2019 was rescinded by the President in pursuance of the Commission's proceeding no. 464/ECI/LET/TERR/TN/SS-1/2019 dated 14.04.2019. The Commission issued Press Note No.ECI/PN/49/2019 dated 16<sup>th</sup> April, 2019 in this regard.

3. Now, the Commission has considered the matter and has decided to hold the General Election of 8-Vellore Parliamentary Constituency of Tamil Nadu. In pursuance of Sections 30 and 56 of the R.P.Act, 1951, as per the programme mentioned as under: -

### ELECTRONIC VOTING MACHINES (EVMs) and VVPATs


The Commission has decided to use EVMs and VVPATs in the election in all the polling stations. Adequate numbers of EVMs and VVPATs have been made available and all steps have been taken to ensure that the polls are conducted smoothly with the help of these machines.

### **IDENTIFICATION OF VOTERS**

In consonance with the past practice, the Commission has decided that the voter's identification shall be mandatory in the aforementioned election at the time of poll. Electoral Photo Identity Cards (EPIC) shall be the main document of identification of a voter. However, in order to ensure that no voter is deprived of his/her franchise, if his/her name figures in the electoral Rolls, separate instructions will be issued to allow additional documents for identification of voters at the time of poll in the said election.

### **MODEL CODE OF CONDUCT**

The Model Code of Conduct shall come into force with immediate effect in the district(s) in which the whole or any part of Parliamentary Constituency going for election is included, subject to partial modification as issued vide Commission's instruction No.437/6/INST/2016-CCS, dated 29<sup>th</sup> June, 2017( available on the Commission's website). The Model Code of conduct shall be applicable to all candidates, political parties and State Government concerned. The Model Code of Conduct shall also be applicable to the Union Government for the district of the State concerned.
