Announcement of the Hon'ble Chief Minister under rule 110 of the Tamil Nadu Legislative Assembly Rules, dated 19.02.2020

Order:-

The Hon'ble Chief Minister has made the following announcement on 19.02.2020 on the Floor of Assembly, under rule 110 of the Tamil Nadu Legislative Assembly Rules:-

“குழந்தைகளுக்காக, குறிப்பாக பெண் குழந்தைகளுக்காக மாண்புமிகு அம்மா அவர்கள் ஆற்றிய உயர்ந்த சேவையினை நினைவு கூரத்தக்க வகையில், அவர்களின் பிறந்த நாளான பிப்ரவரி 24ஆம் தேதியை, “மாநில பெண் குழந்தைகள் பாதுகாப்பு நாளாக” அனுசரிக்க மாண்புமிகு அம்மாவின் அரசு முடிவு செய்துள்ளது”.

2. Accordingly, the Government declare the birthday of the former Hon'ble Chief Minister Dr.J.Jayalalitha ie., 24th of February every year as “**State Girl Child Protection Day**” in the State of Tamil Nadu and permit the Commissioner of Social Defence to take necessary action to observe the “State Girl Child Protection Day” at the State and District level by organizing various activities such as human chain, taking oath/pledge, rallies, seminars, workshops, street plays on girl child protection, etc., on that day and the Oath on Girl Child Protection in all Government offices and schools in the State should also be taken on that day.

3. The Government also permit the Commissioner of Social Defence to incur the expenditure for the above activities from the funds of State Child Protection Society under the component “Awareness generation through IEC materials” and for

District Child Protection Unit under the component "Advocacy and awareness" already sanctioned under the Child Protection Services Scheme.

4. This order issues with the concurrence of Finance Department *vide* its U.O.No.9272/Fin(SW)/2020, dated 20.02.2020.
