இடைநிலை/மேல்நிலை முதலாம் மற்றும் இரண்டாம் ஆண்டு பொதுத்தேர்வுகளில் ஒழுங்கீனச் செயலில் ஈடுபடுவோர் மீது எடுக்கப்படும் நடவடிக்கைகள்

Nature of Offence		Scale of Punishment
1.	Candidates who has in his possession printed books, notes or manuscripts bearing on the subject of the examination but who voluntarily surrenders them without being detected by the Superintendent.	Warning by the Chief Superintendent. If there is repetition of this in the same session of the same examination, the candidate may be expelled after obtaining an on – the – spot written explanation. Subsequent papers may still be answered. The facts should be reported to the Secretary, Board of Higher Secondary Examination, Chennai – 600 006.
2.	A Candidate who is discovered by the Superintendent to be in possession forbidden materials such as printed books, notes or manuscripts etc., but the candidate is not found to have made use of the forbidden material.	Expulsion by the Chief Superintendent after obtaining an on the spot written explanation. Subsequent papers may still be answered. The Scripts and objectionable matter should be sent to concerned District Assistant Director of Government Examinations Cancellation of performance at the examination in case the candidate has not made use of the objectionable matter and cancellation of performance at the examination and debarment for one year, i.e., two subsequent examinations in case the candidate has made use of the objectionable matter.
3.	A candidate detected copying from another candidate or taking help from any in the examination hall or from outside	Expulsion by the Chief Superintendent after obtaining an on the spot written explanation. Subsequent papers may still be answered. Cancellation of performance at the examination and debarment for more than one year. i.e. more than two subsequent examinations depending upon the circumstances and the nature of evidence.

Nature of Offence		Scale of Punishment
4.	A Candidate FOUND GUILTY of copying, attempting to copy from the forbidden papers.	Cancellation of marks at the particular whole session of Examination besides debarring him for the NEXT TWO examinations.
5.	Candidate or his associates influencing the Examiners or other connected in the examination work.	DEBARRING the candidate for specific period, depending on the circumstances and the nature of evidence. (Punishment should be more than Rule No.4)
6.	Impersonation cases	Cancellation of performance at the examination and debarring permanently.
7.	Substitution of answer books.	Cancellation of performance at the examination and debarring for a specified period (more than RULE No.4)
8	Candidates writing objectionable abusive or offensive language, or letters to the examiners requesting them to award pass marks etc. and to the Office of the Director of Government Examinations, Chennai-6.	Cancellation of the performance at the examination or the particular examination.
9.	Misbehaviour of the candidate towards invigilating staff of the examination centre including assault on the invigilation staff either in the examination hall or outside the centre.	Expulsion of the candidate and also not allowing him to sit for the subsequent examination as per the discretion of the Chief Superintendent OR cancellation of performance at the examination and debarring the candidate of specific period or permanently.
10	Taking away the answer books or leaving the examination hall without handing over the answer books to the invigilator whether returned subsequently or not. Candidate tearing the scripts in the hall.	Cancellation of performance in the examination besides the candidate being warned by the Chief Superintendent.
11	Sending out the Question paper	Cancellation of performance at the examination and debarment up to a period of three years i.e. six subsequent examinations.

Nature of Offence		Scale of Punishment
12 .	Refusal to offer and on the spot explanation to the invigilator or Chief Superintendent.	Cancellation of performance at Examination besides debarring for the subsequent examination.
13 .	Copying detected on the basis of internal evidence such as:- (a) During Valuation & (b) During Special Scrutiny	Cancellation of performance besides debarring for two subsequent examinations.
14 .	Exchange of change of Roll Numbers on the answer scripts with a view to give or take help or change of answer books with another candidate.	Cancellation of performance besides debarring the candidate for a maximum period of five years i.e. 10 subsequent examinations
15 .	Writing names, initials, other marks of identification on outside the answer scripts and additional answer books.	A warning or cancellation of performance if necessary after obtaining the explanation of the candidate depending on the circumstances.
16 .	Throwing of question paper after writing the answer on it, to the other candidate	Cancellation of performance
