

03	Names of eligible applicants shall be displayed/names of ineligible applicants shall also be displayed separately with reason for rejection in the school notice board and in the website of Department of School Education.	By 5.00 PM on 11.11.2020
04	If the eligible applications are more than 25% of intake capacity, random selection method shall be adopted.	12.11.2020
05	Names of selected applicants, with application numbers shall be displayed immediately in the notice board and in the website of the Department of School Education.	12.11.2020
06	The schools shall submit written statement to the concerned District level Authority after completion of admission process as prescribed in Form IV.	15.11.2020
