Sub: School Education Department – Public Health – **Birth and Death Registration – Awareness Creation among students and parents on the importance of Birth registration** – Inclusion of Name the child in Birth Certificate- Reg

With reference to the letters cited above, this is to inform that registration of births and deaths is compulsory at the place of occurrence throughout the state as per provision of the registration of birth and death act, 1969 and Tamil Nadu registration of Births and Death Act, 1969 and Tamil Nadu registration of births and deaths rules, 2000.

In this connection, it is informed that Registration of Birth is the right of every child and it's the first step towards establishing her/his legal identity.

The reporting time for registration of Births and Deaths is within 21 days of its occurrence of the event failing which late registration procedures have to be followed as per the provision of Act and Rules.

- A birth can be registered without the name of the child.
- The name of the child can be entered in the birth certificate within 12 months without any fee and after one year but within 15 years 12 months without any fee and after one year but within 15 years from the date of registration of birth on payment of prescribed fee and by approaching the concerned Registrar.
- The name of the child can be registered with the written declaration form by parents/guardian. The name once entered cannot be changed as it is not permissible under the provisions of the act.

In respect of the name registration, further it informed that the system of registration of Births and Deaths was revamped from 01.01.2000 and implemented in the state as per the Tamil Nadu Registration of Births and Deaths Rules, 2000, wherein

- The birth registered prior to 01.01.2000 a time limit up to 31.12.2014 was provided for registering the name of the child.
- An extension of time limit of 5 years i.e., up to 31.12.2019 was given to include the name of the child in the birth certificate for the births registered prior to 01.01.2000.
- In view of the expiry of the above time limit the Government of India has now given the extension of time limit up to 31.12.2024 for name inclusion in the Birth certificate for the cases where the birth has already been registered prior to 01.01.2000 and for the cases for which the time limit of 15 years period got over.

In this regard, all the chief educational and district educational officers are directed to issue suitable instructions to all types of schools to brief the children/parents on the above and exhibit the information on registration of birth in the school premises.

Further all the chief educational Officers are requested to issue suitable instructions to all types of Primary, High and Higher Secondary Headmasters/Headmistress to ensure the name of the child is registered in the Birth Certificate while submitting Birth Certificate at the time of admission and to check the Date of Birth and Name of the child is same as recorded in school records so as to avoid hardship by the students at later date.

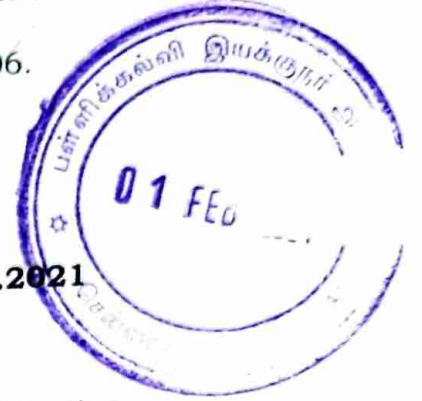

I invite your kind attention and I hope you may be aware that Registration of Births and Deaths is compulsory at the place of occurrence throughout the State as per provision of the Registration of Birth and Death Act, 1969 and Tamil Nadu Registration of Births and Deaths Rules, 2000.

In this connection, I am to inform you that Registration of Birth is the right of every child and it's the first step towards establishing her/his legal identity.

The reporting time for registration of Births and Deaths is within 21 days of its occurrence of the event failing which late registration procedures have to be followed as per the provision of Act and Rules.

Hence, I request you to issue suitable instructions of all concerned to ensure the name of the child is registered in the Birth Certificate while submitting Birth certificate at the time of admission and to check the Date of Birth and Name of the child is same as recorded in school records so as to avoid hardship by the students at later date.

The Government of India have clearly informed that such extension of time limit for name registration will not be provided hereafter and requested to create awareness among the public to attain the goal of universal registration by 2030.

In view of context of extension of time limit of name registration, I request you to create awareness among the children / parents on the importance of Birth registration along with the name of the child to avoid hardship at later date.

I herewith enclose few messages on Birth registration to create awareness and I request you to issue suitable instruction to all concerned to brief the children / parents on the above and exhibit the information on registration of Birth in the school premises.

I will be thankful if you could mark a copy of your instruction issued in this regard.
