Sub: GPF – Missing Credit Clearance Drive – details called for through mail,  
post - Intimated – Regarding.

Ref: FM-II/IV/MCCD-3/2023-24/36289 Dated. 14.12.2023 to CTA.

In order to sensitise the DDOs on the process of clearance of missing credits in the GPF account of the subscribers, it is proposed to conduct Missing Credit Clearance Drive Phase-3 from January 2024 onwards. In this connection, we have also requested the Commissioner of Treasuries and Accounts to extend the cooperation of respective Treasury officers/Pay and Accounts officers to make the GPF Missing Credit Clearance Drive a fruitful one.

Along with this letter we are sending the DDO-wise list of subscribers who are having GPF missing credits prior to 01.04.2016 (soft copy through mail only – both PDF and XLS format). You are requested to take a printout and handover the list to the DDOs concerned with instructions to send the details of missing credits in the prescribed format, duly certified by the DDOs, to AG's office in order to facilitate this special drive and make it more effective and successful.

It is noticed that details for nearly 1.34 lakh missing credits (in respect of GPF/TPF subscribers of all the districts) pertaining to the period prior to March 2016 are yet to be received inspite of the above initiatives taken by this office and further it is observed that 75% of the missing credits cleared during the two phases of MCCD were items for which the subscriptions were not deducted for those months due to various reasons.

In view of the above, it has been decided to give one more opportunity to the subscribers for providing the necessary details before April 2024 for clearance of their missing credits and if the details are not forthcoming it will be presumed that MCs up to February 2016 shown against the subscribers account are no longer missing and the same will be treated as "Not missing" and further such items will not be displayed in the Annual Account Statement from the year 2023-24.
